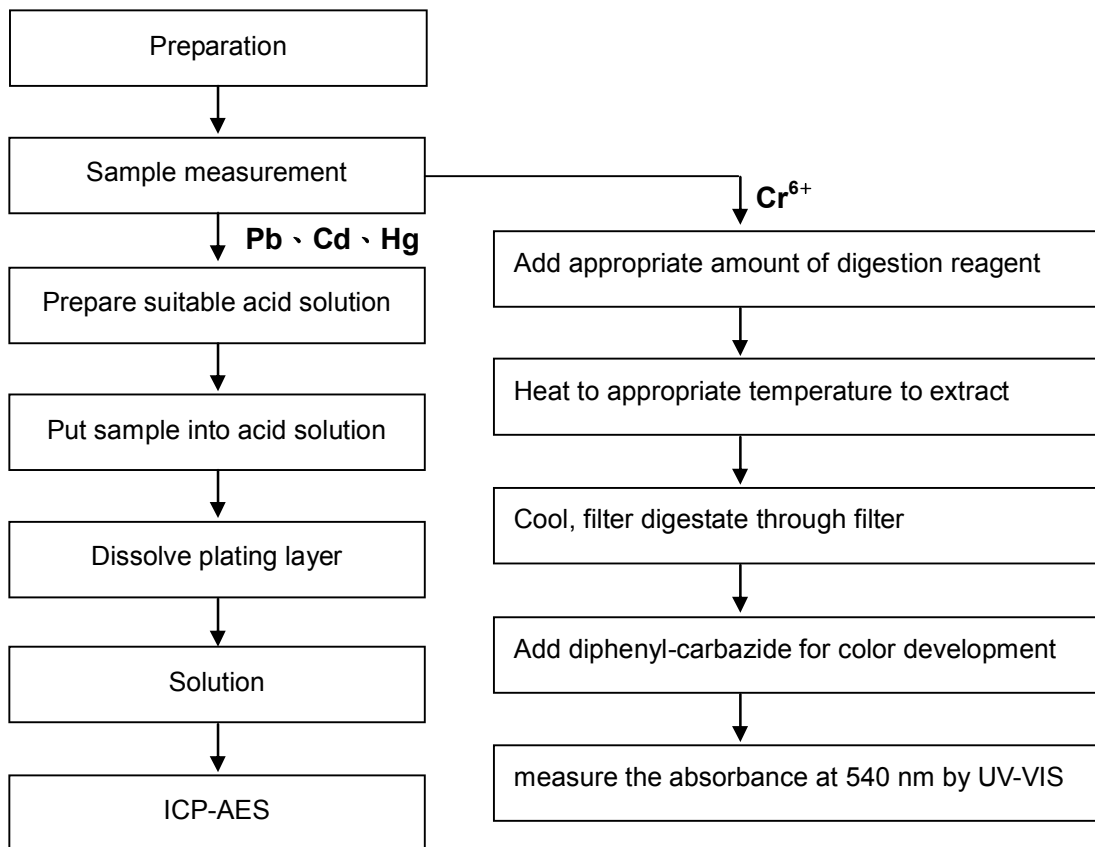

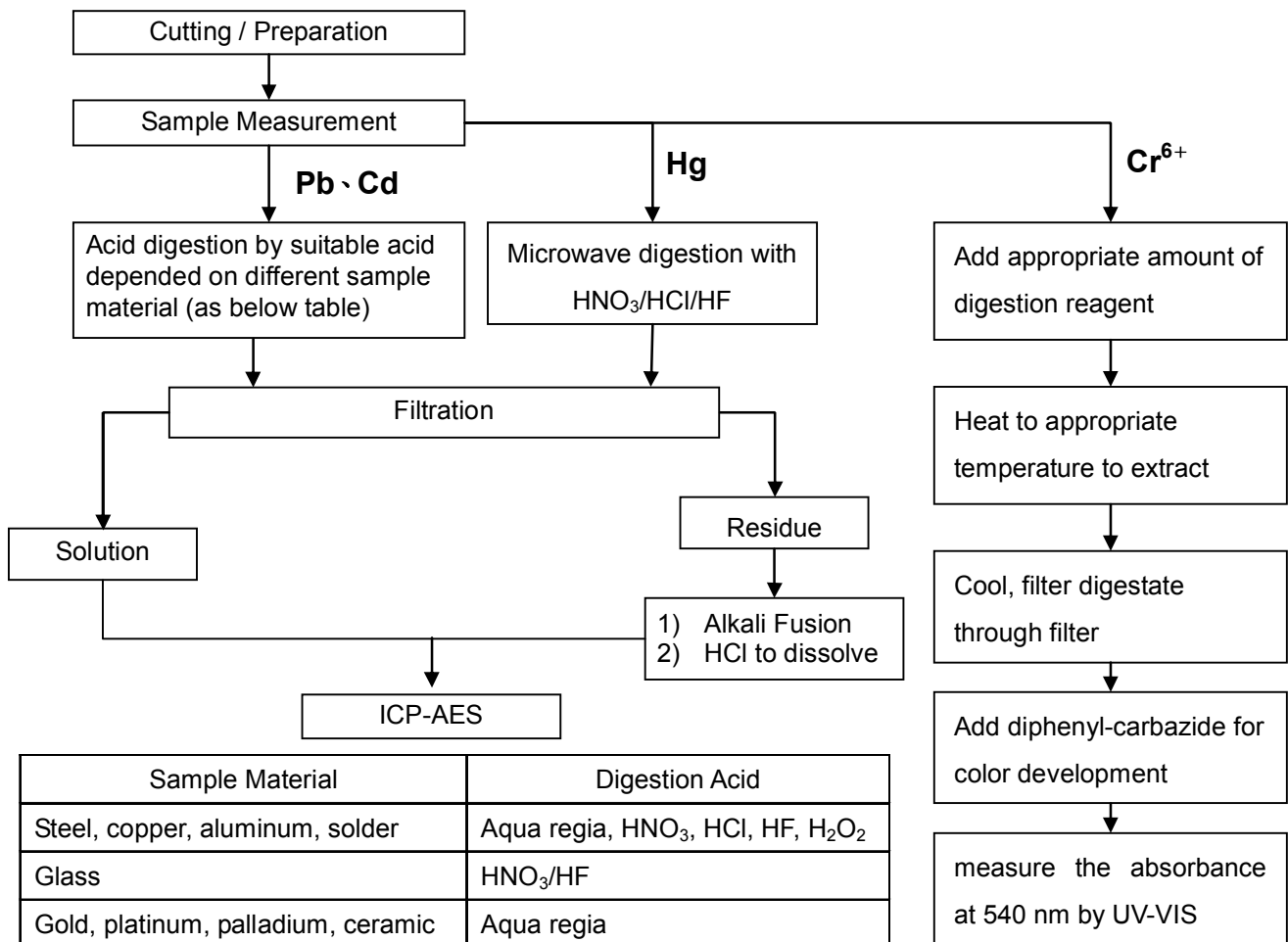

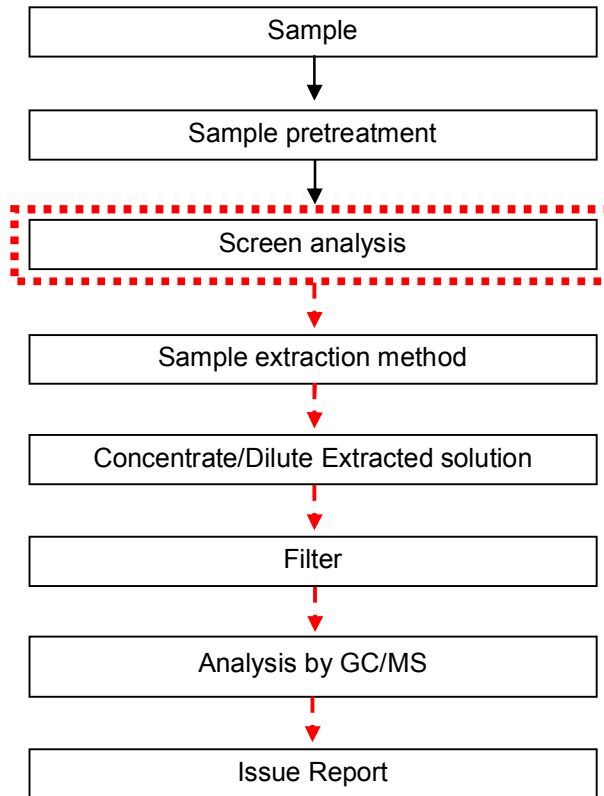


Analytical flow chart

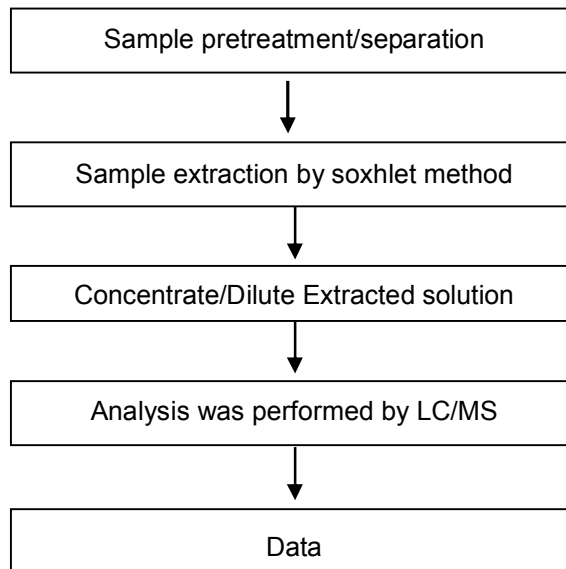

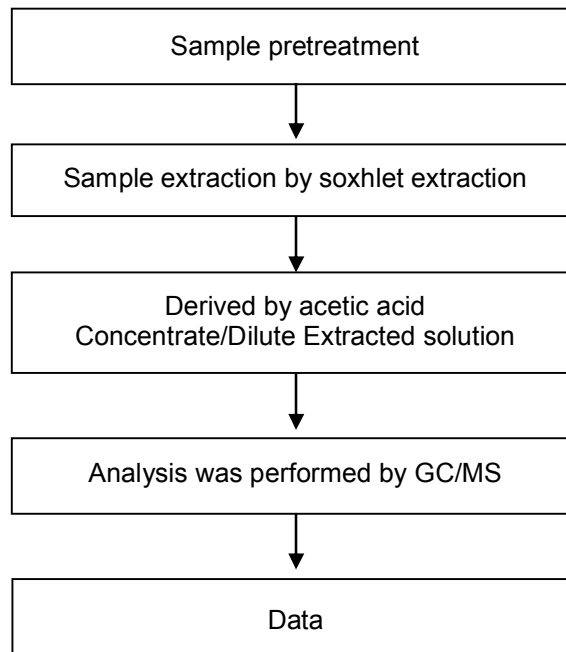

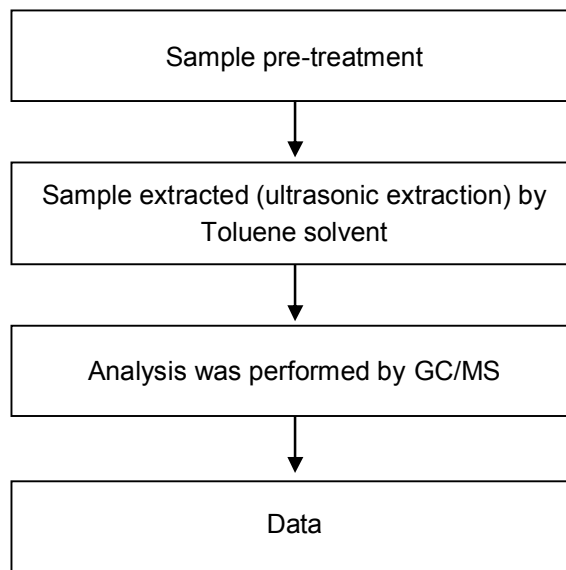

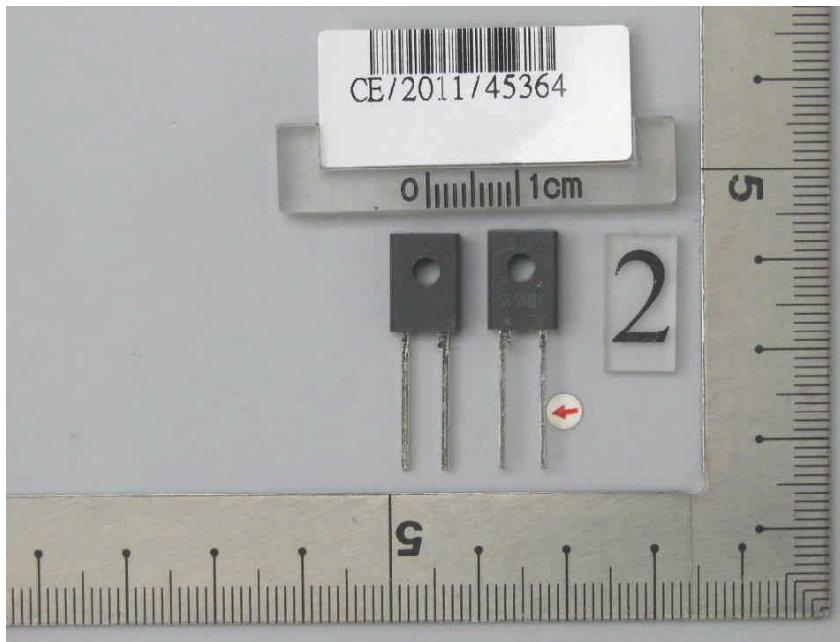
